7. MANAGEMENT 2)

The management of the affairs of the Trust shall vest in the President and Sole Trustee (Founder President / President and Sole:Trustee)


The Sole Trustee shall have authority to constitute an Advisory Committee consisting of not more than 11 (Eleven) members to advices him in the administration of the Trust.



8. POWERS AND DUTIES OF THE ADVISORY COMMITTEE:

To raise funds necessary for the purpose of carrying out the aims and objects of the Trust in the form of donations, deposits,, and grants etc.

To prepare schemes in the interest of the Trust and recommend to the Sole Trustee its implementations and if need be to recommend rising of


To propose creating of cadre of staff required for the administration of loans for the purpose. the Trust and also to assist the recommendation of salaries to be fixed for the staff. Further, also to assist in the appointment and management of the institutions working under the Trust and also the staff working

To advice the Sole Trustee in all legal, administrative and managerial matter relating to the Trust and the institutions working under the Trust.

To make suggestions to the sole trustee regarding the improvements to be made in the affairs of the trust.

There shall be maintained all the accounts of the Trust, as required under the provisions of the Indian Trusts Act 1882 and also the Income Tax Act 1961. The accounts shall be closed on 31st March of every subsequent year and shall be got audited by the auditor who is appointed

in the previous year annual meeting of the Trust by the Sole Trustee in consultation with the Advisory Committee.

2. The Annual Report and the Audited Balance Sheet shall be prepared and placed before the Sole Trustee and the Advisory Committee for

The Trustee may accept any donation or contribution in cash or in kind from any Person, Firm, Company, Corporation, Association, Institution or Trust (including the author of the Trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the Trust. The Trustee may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such Institutions.

Without affecting the generality of powers and functions of the Trustees to manage and administer the trust, the Board of Trustees shall have the following functions.

To borrow if needed, be against the security of the assets of the trust by way of bank overdrafts, loans or otherwise, as may be necessary for the benefit of the trust and for more effectively carrying out the objects of the trust provided. However, the trustees unanimously agree on such borrowing and limit to the terms of their decision or agreement and to authorize two or more of the trustees to execute such document, deeds, papers, etc. as may be necessary in connection thereof.





man for supervision and to look after the day to day expenses and submit the accounts and receipts.

To Invest trust money in any movable or immovable property in the modes specified under the provisions of Sec. 13(I) and read with Sec. 11(5) of the Income Tax Act and further, will have the power to sell or very such investments according to their discretion from time to time subject to the provisions of Sec. 13(i) (d) of Income Tax Act 1961.

The Trustees shall maintain true and accurate accounts in course of management of trust properties.

10. GENERAL:

The President / Founder President and Sole Trustee shall have power to pledge, mortgage, and transfer or alienate any of the trust property/ properties in the better interest of the Trust. He shall have power to grant aid the needy institutions established by him by way of grant, donations, loans and advances etc., either suo moto or in consultation with the Advisory Committee.

The Constitution of the Trust and the working rules of the Trust may be amended or altered or repealed by the Sole Trustee suo moto or in consultation with the Advisory Committee, if he considers it necessary in the interest of the Trust.

No Amendments, alteration or repeals shall be made to the constitution and the working rules of the trust, which may prove to be repugnant to the provisions of the Indian Trusts Act 1882 and the provisions of Secs.

11. AMENDMENT CLAUSE:

"No" amendment to the Trust Deed shall be made which may prove to be repugnant to the provisions of Sec.2(15), 11, 12, and 80-G of the Income Tax Act 1961 as would be amended from time to time.

12. DISSOLUTION CLAUSE:

"In the event of dissolution or winding up of the Trust, the assets remaining after discharge of the liabilities as on the date of dissolution, shall under circumstances be distributed among the Trustees/Members of the Managing Committee/Governing Body, but the same shall be transferred to another Charitable Trust/Society, whose objects are similar to those of this Trust/Society and which enjoys recognition U/Sec.80-G of the Income Tax Act 1961 as amended from time to time"

The Trust formed shall be irrevocable. The benefits of the Trust shall be open to all irrespective of cast, creeds, religion and race sex but can not be claimed as a right from the member of public.

The funds and the income of the Trust/Society/Institution shall be solely utilized for the achievement of the objects and no portion of it shall be utilized for payment to Trustee/Members by way of profit, interest, dividend etc.




